

# Basler Fashion Group to exhibit at CPD as planned

As planned, the Basler Fashion Group will be presenting its new spring/summer collection 2018 at the CPD show (Collection Premiere Düsseldorf). While the company is currently subject to debtor-in-possession proceedings, these are running to plan and its business operations are continuing without restriction.

Ahead of the show, the Group has received positive feedback from its wholesale customers, with over 90% of meetings with buyers already booked. "This is a positive signal for Basler Fashion. We are therefore optimistic that we'll finish the show with a pleasing number of orders," a representative of the company's management team explains. Production and deliveries for the spring/summer 2018 collection is also guaranteed for next year, as the group has fulfilled all necessary conditions for this over the last few weeks. Current deliveries for the autumn/winter 2017/2018 collection are being executed as planned.

Debtor-in-possession proceedings are in-court restructuring proceedings to rescue and rehabilitate financially distressed companies. The company is allowed to manage the restructuring process itself, supervised by an insolvency monitor and generally supported by restructuring experts with relevant experience in this field. The preliminary proceedings, that last between 2 and 3 months, are followed by the main proceedings, in the course of which the creditors can file their claims.
