By decision of 1 July 2014, the court ordered temporary insolvency proceedings and appointed the attorney Dr. Christian Kaufmann as the temporary insolvency administrator of the company and the limited liability company that acts as its general partner.

S + T Sicherheit und Technik GmbH & Co. KG is a Stark Group company and is active throughout Germany. Its services include the surveillance and protection of commercial and private properties. The main reasons for filing for insolvency are the economic problems of the Stark Group. The company currently employs 30 staff.

Business operations are at present being continued, which has been agreed by the temporary insolvency administrator. Dr. Kaufmann, an attorney at PLUTA, is currently studying the company's economic situation, together with possible options for its reorganisation.
