### Emden shipyard Fosen Yard to continue operating

- PLUTA restructuring expert Dr Christian Kaufmann from Oldenburg appointed provisional administrator
- Employee salaries guaranteed for three months
- Business to continue operating despite filing for insolvency

The Local Court of Aurich yesterday ordered provisional insolvency proceedings to be opened for the assets of Fosen Yard Emden GmbH. The court appointed Dr Christian Kaufmann from the Oldenburg branch office of PLUTA Rechtsanwalts GmbH as provisional administrator.

The company operating in the shipbuilding and metal construction sector employs a total of 96 people at its facility in Emden. Dr Christian Kaufmann, the provisional insolvency administrator, stated, "Employee salaries are guaranteed for a period of three months thanks to substitute benefits provided under German insolvency law. The business will initially continue operating at its current level. Most employees are still on short-time working at the moment and the rest have been assigned to other shipyards. The background to this situation is that an order for the construction of six ships has been delayed multiple times. Outstanding issues regarding other orders also have to be clarified. Together with management, we will now
