# Natura-Holzbau GmbH to continue operating

13 October 2022 · Rheine/Münster · Business Area: Insolvency Administration

Natura-Holzbau GmbH based in Rheine near Münster has filed for insolvency. On 29 September 2022, the Local Court of Münster ordered provisional insolvency proceedings to be opened for the company's assets. The court appointed attorney Dr Ria Brüninghoff of PLUTA Rechtsanwalts GmbH as provisional administrator. Together with management, she has been keeping the business operational since the application for insolvency was filed. Work has already been resumed for several construction projects.

The company had to file for insolvency due to liquidity problems caused by, among other things, high raw material prices, delays in material procurement and the cancellation of orders by prime contractors. Restructuring expert Dr Brüninghoff has analysed the timber construction company's current situation in recent days. She said, "We've already held in-depth discussions with business partners, customers and suppliers. These have been overwhelmingly positive and it has already been possible to resume work on several projects. This is a good basis for the coming weeks. However, given the current state of discussions, full resumption of all construction activities is unlikely as the relevant construction contracts were cancelled by the prime contractors. However, we are in further talks regarding this."

The provisional insolvency administrator and managing director Mr Jörg Streiter already informed the 75 employees of the current situation during a meeting. "The salaries are guaranteed thanks to specific substitute benefits provided under German insolvency law. Although things are not especially easy at the various construction sites at this juncture, the employees are motivated and have signalled their support to us, which I greatly appreciate," said managing director Mr Streiter.

The provisional administrator and her team aim to find a viable follow-up solution for the business (or significant parts thereof) and save as many jobs as possible. Crucial to this is whether a buyer willing to acquire and invest in the business can be found. "We are reviewing all options and will actively approach relevant companies in the market," said Dr Brüninghoff. She is being supported in the PLUTA restructuring team by attorney Ms Stefanie Breitenströter-Brüggemann and business lawyer Mr Tim Austmeyer.
