# Neumann Group Calendar Specialists take over Arti Kalender & Promotion Service

The Neumann Group, a Kiel-based calendar specialist enterprise, has taken over Arti Kalender & Promotion Service GmbH domiciled in Herzebrock-Clarholz as part of a restructuring process involving an asset transfer. The purchase agreement was signed in mid-March. However, the parties have agreed to maintain silence on the purchase price. Both the provisional creditors' assembly and the attorney Mr Stefan Meyer, a partner at the law firm PLUTA Rechtsanwalts GmbH who is acting as the insolvency monitor in these proceedings, have given their consent to the sale. The business operations were transferred on 1 April 2018. The sale of Arti ensured that 71 of the original 121 jobs were saved. Those members of staff not kept on by the investor will join an employment and qualification company. The new company will in future be named arti Promotion GmbH.

recovery rate. This means that the unsecured creditors should probably receive an above-average recovery rate of between 60 and 70 per cent. By way of comparison, according to Germany's Federal Statistical Office, the average recovery rate in ordinary insolvency proceedings is between three and four per cent.

In debtor-in-possession proceedings, the previous board of directors continue to be responsible for business operations. In this case, Mr Heinz-Peter Derrix-Belau (Buchalik Brömmekamp) provided support for the management of Arti Kalender & Promotion Service GmbH in his role as the chief restructuring officer. During the debtor-in-possession proceedings, the board of directors are under the supervision of an insolvency monitor. The Local Court of Bielefeld had appointed the restructuring expert Mr Stefan Meyer, a partner at the law firm PLUTA Rechtsanwalts GmbH, as the insolvency monitor. The PLUTA team also includes the attorney Mr Christoph Chrobok in addition to the insolvency monitor appointed.

Mr Stefan Meyer commented on the success of the restructuring measures as follows, "I am delighted not only for the creditors, but also for the employees who kept their jobs. The staff did excellent work during the proceedings, despite justified concerns about their jobs.
