PLUTA attorney Dr Kaufmann appointed as provisional administrator of the coach operator Gerhard Paul von Grönheim

The Local Court of Cloppenburg in the German federal state of Lower Saxony has ordered provisional insolvency administration for the assets of the coach operator Gerhard Paul von Grönheim on 7 June 2019. Dr Christian Kaufmann, a restructuring expert from PLUTA Rechtsanwalts GmbH, was appointed as the provisional administrator. Filing for insolvency became inevitable for the company due to liquidity problems.

Gerhard Paul von Grönheim operates the business as a sole proprietorship, which is based in the Pirgo industry park in Friesoythe, Lower Saxony, and currently has a workforce of 96 full-time and part-time employees. His coach company mainly focuses on transporting passengers in the charitable and social area. Each day, up to 500 disabled children and juveniles are brought to school and similar establishments with 53 vehicles. The company's business has been maintained without any interruption since the application was filed. This means that the transport of the children in the Southern Oldenburg Region has been secured.
