PLUTA attorney Dr Kaufmann appointed provisional administrator for forwarder Lottmann from Aurich

On 10 November 2020, the Local Court of Aurich ordered provisional insolvency proceedings to be opened for the assets of Lottmann GmbH & Co. KG. The court appointed Dr Christian Kaufmann from PLUTA Rechtsanwalts GmbH as provisional insolvency administrator for the forwarder from Aurich in Lower Saxony.

The company has had to file for insolvency due to liquidity problems. It has been agreed with management at the long-standing forwarder that business operations will be maintained without restrictions. All customers will receive their deliveries as usual, in compliance with hygiene requirements. The company based in East Frisia, a region in Lower Saxony, has a staff of 17 employees, whose salaries are guaranteed thanks to specific substitute benefits provided under German insolvency law.
