# PLUTA Attorney Mr Wahl looking for an Investor for Wochenblatt Verlag Ravensburg

As part of the process to find an investor for Wochenblatt Verlag Ravensburg GmbH & Co. KG, Mr Michael Wahl from PLUTA Rechtsanwalts GmbH has now held initial talks with prospective buyers. The attorney has been appointed as the provisional insolvency administrator for the company by the Local Court of Ravensburg at the beginning of December.

The publishing house publishes the "Wochenblatt", a local advertising paper that appears in Ravensburg, Bad Saulgau, Biberach, Riedlingen, Friedrichshafen, Lindau, Tuttlingen and Wangen. The issues that appeared on 7 and 14 December were produced on schedule. However, no other issues have been planned for the time being.

The PLUTA expert said, "The current situation is not easy. I have held initial talks with two potential investors, but it is not currently clear whether it will be possible to find an investor. We need to achieve a solution by January 2018, otherwise we will have to shut down the business operations."

In the meantime, the local court has also ordered that preliminary insolvency proceedings be opened for two subsidiaries and has appointed the business management
