The attorney said, "The business is still fully operational. This means that all patients are being well looked after and will continue to receive the usual level of care from staff. I am currently preparing the pre-financing of insolvency substitute benefits together with my team. This will ensure that the 45 employees continue to receive their pay as normal." Those responsible have already informed the employees about the latest developments.

Restructuring expert Mr Roeger continued, "We are currently gaining an overview of the financial situation and will review all restructuring options for the business." The PLUTA restructuring team includes business lawyer Mr
