PLUTA expert Ivo-Meinert Willrodt appointed provisional administrator for Bäumler Fashion

Bäumler Fashion GmbH has filed for insolvency proceedings to be opened for its assets. On 8 October 2020, the Local Court of Ingolstadt ordered provisional insolvency proceedings and appointed Mr Ivo-Meinert Willrodt from PLUTA Rechtsanwalts GmbH as provisional administrator. The fashion house based in Ingolstadt has had to file for insolvency due to liquidity problems as it has recently seen significant declines in sales due to the COVID-19 pandemic.

The company has ties with the Edinburgh Woollen Mill Group (EWM) in England. In recent years, in addition to its domestic market in Germany, men's outfitter Bäumler has been able to establish itself in international markets such as Canada, the UK and Russia by taking advantage of the EWM Group's sales and production structures. Sales, marketing and product design are handled out of Ingolstadt. Menswear was produced at an external production facility in Hungary, where Bäumler's premium suits were manufactured.

"The members of the PLUTA team are currently in the process of gaining an initial overview of the company's financial situation. The business is continuing to operate.
