Following the decision taken on 10 April 2017, the Local Court of Göppingen has appointed Mr Michael Wahl from PLUTA Rechtsanwalts GmbH as the provisional insolvency administrator of the fibre composite technology company Kunststoff Wagner GmbH.

The restructuring expert will arrange the pre-financing of the insolvency substitute benefits as soon as possible. Employee wages and salaries will be secure for a period of three months thanks to these benefits.

"It is my aim to ensure that the company has good prospects of continuation and to save the jobs. In order to achieve this, we will closely analyse the economic situation of the company and examine the restructuring options," explained the PLUTA attorney Michael Wahl.
