# PLUTA Expert Stefan Meyer appointed as provisional Insolvency Monitor for Hellmann Fleischwarenfabrik GmbH & Co. KG - Restructuring Plan is being drafted

Following its decision on 7 July 2017, the Local Court of Bielefeld has ordered debtor-in-possession management for the meat products company R. Hellmann Fleischwarenfabrik GmbH & Co. KG in Bünde. The debtorin-possession proceedings will be overseen by the attorney and insolvency consultant Mr Joachim Walterscheid from the law firm Walterscheid Rechtsanwaltsgesellschaft mbH, who has already successfully supervised many debtor-in-possession and restructuring proceedings in the past few years. Mr Stefan Meyer from PLUTA Rechtsanwalts GmbH was appointed as the provisional insolvency monitor by the insolvency court and approved by the provisional committee of creditors. The company will be restructured and prepared for the future in the coming months, and a restructuring process has already been introduced as part of the debtor-inpossession proceedings.

The company's financial difficulties have primarily been

caused by a fire in the production area in March of this year and by the production-related delay in repairing the damage and settling the matter with the insurer, a process which has not yet been concluded.

Currently the company has a workforce of 67 employees whose salaries are secure for a period of three months thanks to the so-called insolvency substitute benefits. Business operations will be continued without restriction. In the coming weeks, a comprehensive restructuring plan will be devised, which should help to make the company fit for the future on a sustained basis.

"The customers and suppliers have remained loyal to the company. Moreover, the employees are pulling together with the management. I am therefore confident that we can complete the restructuring process successfully," said the insolvency monitor Mr Stefan Meyer. The managing director Mr J.F. Hellmann and the attorney Mr Joachim Walterscheid added: "The company took timely action when filing for debtor-in-possession proceedings.

Moreover, by producing salami, Hellmann has now found a niche in the strongly contested meat products market. It is our goal is to save both the company and the jobs."
