PLUTA restructuring expert Dr Kaufmann secures DUHA's future

Dr Christian Kaufmann from PLUTA Rechtsanwalts GmbH has successfully completed the process to find an investor for DUHA Fertigteilbau GmbH based in Haselünne in the Emsland region. The restructuring expert has achieved a follow-up solution for the company, which specialises in the manufacture of prefabricated concrete elements. Effective 1 December 2021, the business has been sold by way of an asset deal to a company in the Mainka Group headquartered in Lingen.

The parties involved have agreed not to disclose the purchase price. All 78 current employees will be kept on by the buyer and no compulsory redundancies have been required. A few members of staff had already left the company of their own accord during the provisional proceedings. The company headquarters will remain in Haselünne.

"We held countless discussions with a multitude of interested parties. All in all, investor interest in the prefabrication plant and its versatile production possibilities was very high. The solution that has now been reached for DUHA represents the best possible outcome for the business and creditors," said PLUTA attorney Dr Kaufmann.
