Klar Agentur GmbH, a newly founded company, has acquired the business by way of an asset deal effective 1 November 2023. The new company's shareholders include the employees and the managing director.

K-lar GmbH had had to file for insolvency due to liquidity problems, as sales had declined since the COVID-19 crisis and budgets had been cut. The agency's well-known clients were still supported during the proceedings and
