# PLUTA Restructuring Expert succeeds in finding first Investors for the Hock Companies in Saxony

Insolvency administrator Dr Stephan Thiemann from PLUTA Rechtsanwalts GmbH has succeeded in implementing restructuring measures for the Hock Companies in Saxony by way of an asset transfer. The contracts with the purchasers have already been signed. The parties have agreed to maintain silence on the purchase prices. The Hock Companies from Grünhain-Beierfeld supply parts to the car and electrical industries. However, in May 2016 they had to file for insolvency. The Local Court of Chemnitz then opened insolvency proceedings for the two companies in the Hock Group in July 2016.

Six months later, the PLUTA restructuring expert sold Werkzeugbau Weigel GmbH with effect from 1 January 2017. All the 27 jobs at the Rittersgrün site have been saved. The purchaser is the Wustermark-based company J&S Werkzeugbau Weigel GmbH, a subsidiary of J&S GmbH Automotive Technology. The supplier of parts to the car industry was founded in 1990 and manufactures seals, punched and bent parts, welded steel structures, guard plates, belt deflection fittings and airbag elements for the car industry.

As regards Hock Sachsen GmbH, the insolvency administrator Dr Stephan Thiemann managed to sell an individual business unit in Schwarzenberg. This is the special Metal Injection Moulding (MIM) unit with a staff of 44 employees. The assets are due to be transferred on 1 February 2017. The purchaser is Reich MIM GmbH. The companies belonging to Reich group are leading manufacturers of turned parts, ball bearings, components for injection systems and other car parts. The products are used in a variety of areas ranging from the car industry, power tools, apparatus manufacturing and mechanical engineering to the food industry.

The full scope of the business operations of Hock Sachsen GmbH's other business units will be continued. At present, talks are taking place with investors concerning these units. The company has a total workforce of approximately 300. All the deliveries to customers will be made on time, and the order situation is positive.
