# Restructuring Expert Dr Thiemann sells JT Touristik to Lidl E-Commerce

The provisional insolvency administrator Dr Stephan Thiemann from PLUTA Rechtsanwalts GmbH managed to sell the Berlin-based tour operator JT Touristik to Lidl E-Commerce International GmbH & Co. KG. The transaction is subject to approval by the responsible anti-trust authorities and is expected to be completed early in 2018. At that point in time, the buyer will take over the business activities and will ensure continued operation of the company without any restrictions. The company brand "JT Touristik" will be preserved.

The persons responsible have signed the purchase agreement on Saturday. All of the 60 jobs have been saved. The two parties have agreed to maintain confidentiality about the purchase price.

For the customers, this transaction provides the advantage that it will now be possible to organise the booked trips as planned – also next year. Selling the company to an investor means for the customers that they can continue to rely on JT's expertise in future as the previous
