At the beginning of May 2016, the Hock Group had to file for the insolvency of the eight companies in the group. The group of suppliers of the car and electrical industry currently has a workforce 800 employees working at five sites in Germany and at one site in Romania. However, the foreign company is not affected by insolvency.

The internationally operating group of companies has been supplying the car and electrical industry for more than 65 years. The Hock Group mainly produces tin and plastic parts as well as metal parts using powder injection moulding for renowned customers. The company is well
