Restructuring of Bagel Bakery making Progress

The Local Court of Halle (Saale) opened the insolvency proceedings for the assets of Bagel Bakery GmbH on 1 July 2018. The proceedings will continue to be pursued under debtor-in-possession management. The initial steps for reorienting the company have already been identified and were implemented during the application process. This means that considerable progress is being made in restructuring the producer of American bakery products. The measures taken are based on a comprehensive restructuring concept, which has been developed and is being implementing by the managing directors of the company together with the Berlin-based business consultancy Buchalik Brömmekamp. Business operations will be continued without any changes or restrictions, even after the proceedings have been opened.

Bagel Bakery GmbH produces American bakery products for the gastronomy sector, bakery business and trade. Approximately 180 employees produce bagels, muffins, brownies and cookies at the production site in Gutenborn. The main restructuring approach aims at optimising and

planning production more efficiently. Furthermore, the financing structure is to be adapted so that the high credit costs arising from the investment in a production line can be reduced.

Bagel Bakery had filed for debtor-in-possession proceedings with the Local Court of Halle (Saale) at the beginning of April this year. "Our customers and suppliers stayed onboard and are supporting the course we have taken. Therefore, we have been able to continue production and business operations since we filed for insolvency," explained Mr Christian Kiefer, Managing Director.

"Thanks to debtor-in-possession management, we have been able to pursue our goal of turning the company around on a sustained basis and restructuring it so that it is once more competitive. Continued high appreciation among our customers shows us that Bagel Bakery creates the right products. That is an important requirement for continuing business," commented Mr Nils Aeverbeck, restructuring expert from Buchalik Brömmekamp, who is giving support to the company's management board. Buchalik Brömmekamp is also providing the producer of baked goods with advice on legal issues involved in the debtor-in-possession proceedings and is implementing both business and operational restructuring measures.

As a debtor in possession, Bagel Bakery is taking advantage of the new opportunities offered by the insolvency law reform, which took effect in March 2012. In such proceedings, the managing directors remain in charge and, while being protected under the status of

This plan sets out how a company's debts can be reduced and how the business can be continued. Following a judicial review, the insolvency plan then has to be approved by the creditors involved. During the debtor-in-possession proceedings, the company is under the sole supervision of an insolvency monitor appointed by the Local Court of Halle (Saale). Dr Stephan Thiemann from PLUTA Rechtsanwalts GmbH was appointed to this role. He had already been active as the provisional insolvency monitor in these proceedings.
