# Restructuring process for Bagel Bakery successfully completed

The Local Court of Halle (Saale) has successfully brought to an end the debtor-in-possession proceedings, which had been opened on 1 July 2018, for Bagel Bakery GmbH, a producer of American bakery products. In June, the creditors had unanimously approved the insolvency plan submitted by the company. The plan was also approved by the Local Court of Halle (Saale). Both approvals were required to terminate the proceedings.

The aim of the procedure was to implement restructuring measures in such areas as the production of the bakery products. The company's business operations have been maintained without restrictions since the application was filed. The restructuring measures were supported by the Berlin-based law and business consultancy Buchalik Brömmekamp. The insolvency monitor Dr Stephan Thiemann from PLUTA Rechtsanwalts GmbH oversaw the proceedings in the interests of the creditors. Bagel Bakery has a workforce of approximately 150 employees. The company's headquarters are in Gutenborn in the federal state of Saxony-Anhalt. This is

translated into an insolvency plan. The insolvency plan sets out how a company's debts can be reduced and how the business can be saved. Following a judicial review, the insolvency plan then has to be approved by the creditors involved. During the debtor-in-possession proceedings, the company is under the sole supervision of an insolvency monitor appointed by the Local Court of Halle (Saale). "It was only possible to save and restructure the Bagel Bakery under today's difficult competitive conditions because suppliers, customers and employees remained loyal to the company. Restructuring the company under debtor-in-possession proceedings was the best possible option, especially for the creditors," explained the insolvency monitor Dr Stephan Thiemann.
