## SCONVEY Business to be shut down

31 July 2018 · Ulm, Germany · Business Area: Insolvency Administration

SCONVEY GmbH, based in Giengen an der Brenz, has to wind down business operations. In spite of numerous talks with several potential investors, the insolvency administrator Mr Michael Pluta from the restructuring company PLUTA was unable to find a buyer for the company.

The employees were informed of the closure today during a staff meeting. 47 members of staff in total were given their notice. 30 employees have already left the company of their own accord to look for opportunities elsewhere. At the time of filing for insolvency, the company had employed 77 people.

The administrator Mr Michael Pluta negotiated with the works council and the trade union and reached agreement on a reconciliation of interests and a social compensation plan. Production will probably be continued until October 2018 when the remaining orders and any new small orders will be completed.

In the past weeks, Mr Michael Pluta, with the help of his team, has continued business operations and at the same time tried to find an investor. Unfortunately though, no investor could be found. For this reason, and in view of the recent deterioration in the order situation, the administrator will be forced to wind down business operations in the near future since the company is not
