

# Teilzeit Thiele to become Part of the TEMPTON Group

Teilzeit Thiele is a pioneer in the area of staffing services, which was founded as a family business in 1969 and is now managed by Ms Alexandra Thiele, a member of the second generation of the founding family. At the end of last year, in-court restructuring proceedings were initiated (after an application for debtor-in-possession proceedings / insolvency application had been filed). The group of companies consists of a total of eight firms and is one of the market leaders in the regions where it is active. When Teilzeit Thiele submitted the application, there were approximately 1,500 members of staff working at 17 locations in East Westphalia-Lippe, on the northern edge of the Ruhr region, in Lower Saxony and in Saxony-Anhalt. The group is also one of the largest employers in the East Westphalia-Lippe region, where it has its roots.

As a result of the reverberations from loss-making business transactions outside of the group's actual business activity, Teilzeit Thiele had to file for insolvency in December 2018. On 1 February 2019, debtor-in-possession proceedings were opened.

During these proceedings, the enterprise was successfully
